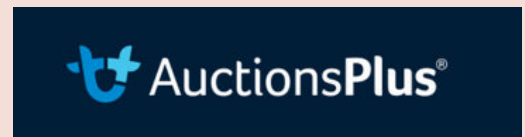
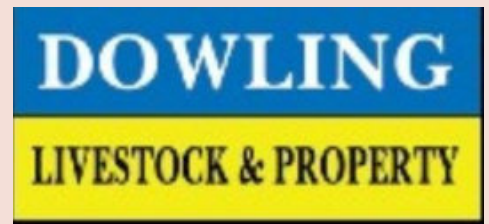

Nominations Open via Campdraft Central ([www.campdraftcentral.com.au](http://www.campdraftcentral.com.au)) Wednesday March 27th 2024 and will stay open for 24 hours. Full nomination fees must be received by 5.00pm Thursday April 4th 2024 via direct deposit. Competitors whose nomination fees are not received by this time, on this date, will have their nominations scratched from the draft by the committee.

The committee reserves the right to alter or cancel any events and reserves the right to alter the order in which the events run

All competitors must be financial with the ACA at the time of nominating

ACA requires all Competitors to ensure all details mirror that of their ACA member and horse profiles, across all non Campdraft One nomination platforms.

Nominations to be completed via Campdraft Central. Nominations will not be accepted without all information

Nominations to be completed in preferred order of runs for horse named

No rider under the age of 17 to compete throughout the weekend.

Riders under the age of 18 must wear helmets whilst mounted on a horse at all ACA-affiliated events. Helmets must comply with current Australian and New Zealand safety standards and must be securely fastened under the chin at all times.

No rider/horse substitution without prior approval by Campdraft Secretary, horses to run as drawn

Scratchings- A 100% refund of the nomination fee will be given if the competitor withdraws more than 168 hours (7 days) prior to 8:00am on the first morning of the program. If a competitor withdraws less than 168 hours (7 days prior to 8:00am on the first morning of the program), then the entire nomination fee may be retained by the committee. If the committee deems that extenuating circumstances apply, then a refund may be granted. Each case will be at the discretion of the committee.

Changes to horse/rider must be done in writing at the secretary's office no later than 1 hour before each event begins. NO CHANGES WILL BE ACCEPTED DURING EACH EVENT OR AT THE ANNOUNCER'S OFFICE

Refunds and prize money will be paid out by direct deposit following the event. To receive payment promptly competitors are requested to ensure their current banking details are provided on Campdraft Central.

All competitors compete at their own risk

All prize money is GST inclusive

All competitors must complete a horse health declaration on arrival to Wandoan Showgrounds.

**HORSE'S STATUS:** The status of a horse winning a campdraft will be determined by the highest class of horse that competes with the exception of Juniors, Juveniles, Ladies, Mens, Old Buffers, Associates and Encouragement campdrafts. The winner attains the status of the highest class of horse participating (eg if one Open horse competes then it is classed as an Open draft).

Any competitor who wishes to lodge a complaint at an affiliated campdraft must lodge the complaint in writing with the secretary of the host committee within one hour of the incident taking place. A fee of \$100 must be paid when the complaint is lodged. If the complaint is dismissed by the Committee, the \$100 is forfeited.
