~ Conditions of Entry ~

All competitors ride at their own risk and must be ready to compete when called.

Any dispute will be settled by the Widgee Campdraft Committee.

Any competitor who wishes to lodge a complaint must lodge the complaint in writing with the secretary within one (1) hour of the incident taking place. A fee of \$20 must be lodged with the complaint. If the complaint is dismissed by the committee, the \$20 is forfeited.

Riders under the age of 18 must wear helmets whilst mounted on a horse during the event.

Helmets must comply with current safety standards and must be securely fastened under the chin at all times.

The committee has the right to alter, add or eliminate any event from the program.

The committee may ask competitors to shorten up yard sizes so more trucks can fit in.

Nominating for the draft deems that the competitors have read and understood the conditions.

A 100% refund of the nomination fee will be given if the competitor withdraws more than 7 days prior to 8 am on the first morning of the program. If a competitor withdraws less than 7 days prior to 8 am on the first morning of the program, then the entire nomination fee may be retained at the discretion of the Committee. If the Committee deems that extenuating circumstances apply, then a refund may be granted. Each case will be at the discretion of the Committee.

If the event is canceled, all nominations will be refunded in full.
