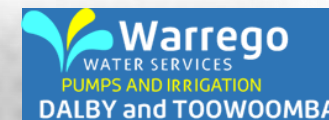

Conditions of Entry

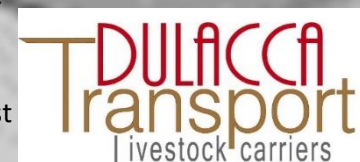
- Dulacca Sports Club is affiliated with CCA and is run in accordance with their General Information, Rules and Recommendations. All competitors must be a CCA member to compete.
- The Committee reserves the right to alter or amend the program at any time & reserves the right to refuse entries without reason
- Nominations via Campdraft Central opening 8 am Wednesday 24th July for 24 hours
- Full payment for nominations as direct deposit as per Campdraft Central Invoice must be received by 3pm Friday 2nd August, unpaid nominations will be scratched
- Nominations are not refundable when cancellations are made with in seven (7) days of the commencement of the draft, except under extenuating circumstances at the discretion of the committee, a refund applied and a \$20 cattle levy retained by the committee
- All horses are to be run as drawn order in draft. NO changes to the draws will be made after ONE HOUR prior to the start of each event

- All competitors compete at their own risk
- Judges' decision in all cases will be FINAL
- Any competitor who, in the opinion of the Executive Committee and/or Chief Steward, deliberately mistreats or abuses stock will be disqualified from the event and participating in any further events on the program & no refund of nomination will be offered
- All riders Under 18yrs MUST wear approved helmets while riding on the grounds (refer to Rule 19 of CCA General Rules and Guidelines)
- All stallions to be contained on the grounds as per CCA rule 11.12. Under no circumstances are members under the age of 17yrs permitted to ride/handle stallions within the perimeter of the grounds
- If required, Horse Health Declarations must accompany horses when travelling. Declaration must be completed and presented to the Secretaries office upon arrival. Dulacca Sports Club PIC Number QEMR 0585.
- Any competitors who, in the opinion of the Executive Committee and/or Chief Steward, deliberately mistreats or abuses stock will be disqualified from the event and also from participating in any further events on

the program. No refund of nominations will be offered

- All dogs must be always kept on a leash and/or be kept securely tied up whilst on the grounds
