CONDITIONS OF ENTRY:

- 1. Program is Campdraft Central Association Inc. affiliated & run in accordance with the General Information Rules & Recommendations. All Competitors to pay \$10 Membership fee, select Event when adding your nominations..
- 2. The committee reserves the right to alter the program at any time.
- 3. The Brymaroo Campdraft Committee does not accept responsibility for any accident, damage, injury or illness to horse, rider, spectator, or any other person or property whatsoever
- 4. Nominate Horses in the order you wish to ride them
- 5. Judge's decision in all cases is FINAL.
- 6. All campdrafts are to be won outright.
- 7. All horses are to be run as drawn order in draft. No changes to the draws will be made after 60 mins prior to the start of each event. In the case of the first draft of the day, changes must be completed by 5:30pm the previous day.
- 8. If a competitor changes a nomination (horse/rider) from the original draw after the start of that event, that run may be disqualified at the committee's direction unless when extenuating circumstances apply.
- 9. All riders Under 18yrs MUST wear approved helmets while riding on the grounds (refer to Rule 19 of CCA General Rules and Guidelines).
- 10. Under no circumstances are members under the age of 17yrs permitted to ride/handle stallions within the perimeter of the grounds
- 11. All stallions are to be contained.
- 12. All dogs must be always kept on a leash and/or be kept securely tied up whilst on the grounds.
- 13. Any competitors who, in the opinion of the Executive Committee and/or Chief Steward, deliberately mistreats or abuses stock will be disqualified from the event and also from participating in any further events on the program. No refund of nominations will be offered.
- 14. Once a draft has commenced, under no circumstances is any competing rider or person on horseback permitted to exit the Camp Area via the side entry gate to the Camp. All persons cracked off in the camp must exit the camp via the front camp gates. This is for the safety of all riders, horses and persons
