## Biosecurity Requirements

**Location: 8861 New England Highway, Glen Innes, NSW, 2370**

"Stonehenge" property is currently subject to a NSW DPI Individual Biosecurity Direction (IBD) under NSW Biosecurity Act 2015, and additional biosecurity measures apply to the entry and exit of livestock and other carriers for the event, and all biosecurity documents must be supplied to the Secretary prior to arrival. The IBD imposes movement restrictions on livestock and other carriers to manage the biosecurity risk. The conditions set out in the IBDs are legally enforceable under the Act. Failure to comply may result in penalties. NOTE: The DPI have not found cattle ticks during their inspections of the livestock, and we appreciate your compliance with all restrictions to ensure this status is maintained until the IBD is lifted.

Entry to the property will be restricted - ensure full communication with the Secretary in advance of weekend. Failure to comply with biosecurity requirements will result in refusal of entry at the gate and/or delayed departure.

All vehicles and persons entering the property will be recorded.

**Horses are only permitted to depart the property Sunday 8th March 2026 between 9:00am and 7:00pm.**

All competitors must load the NSW DPI Cattle Tick app on their phone (iOS/iPhone only) or access the website -  
<https://app-cattletick.bfs.dpi.nsw.gov.au/login>, and create an account.

### PRIOR TO ARRIVAL

1. NSW DPI Record of Movement (Arrival) - Competitors must complete a NSW DPI Record of Movement for horses, which can be completed up to 24h prior to arrival.
  - i) All horses from QLD and NSW Restricted properties must supply a Biosecurity Certificate from an Authorised Officer (Self-certification not permitted).
  - ii) A NSW DPI Record of Movement is completed online via the NSW DPI Cattle Tick app
  - iii) A copy of the Record of Movement must be supplied to the Secretary prior to entry to the property. Email submission is preferred and can be completed within the Record of Movement.
  - iv) The Record of Movement Reference Number must be presented at the gate for entry.
2. Horse Health Declaration – Competitors must supply a Horse Health Declaration prior to arrival. Email submission preferred.
3. Commodity Vendor Declarations must be supplied for any hay brought onto the property. Email submission preferred.
4. No dogs are permitted entry to the property at any time.

### PRIOR TO DEPARTURE

1. Horses Inspected and Sprayed - Horses must be inspected and sprayed by the NSW DPI Authorised Officer and a Biosecurity Certificate issued.
2. Inspection Times – The NSW DPI Authorised Officer will be inspecting horses: Sunday 8th March 2026 between 9:00am and 7:00pm.
3. The NSW DPI Authorised Officer will review the Record of Movement (Arrival) and, for any horses from QLD or NSW restricted properties, the Biosecurity Certificate.
4. NSW DPI Record of Movement (Departure) - Competitors must complete a NSW DPI Record of Movement for horses, after Biosecurity Certificate issued, and prior to departure.
  - i) A NSW DPI Record of Movement is completed online via the NSW DPI Cattle Tick app.
  - ii) A copy of the Record of Movement must be supplied to the Secretary prior to exit of the property. Email submission is preferred and can be completed within the Record of Movement.
  - iii) The Record of Movement Reference Number must be presented at the gate for exit.

I acknowledge that there is a possibility that horses might become infected with disease agents as a result of any movements and if necessary animals and premises will be placed on a restricted list in accordance with any Legislation covering such occurrences including policies and procedures in effect at that time. I agree and acknowledge that the Manager/Event Organising Committee, its State or National Affiliated bodies and their members are not in any way liable for any cost, expense, loss, damage, claim, action, proceeding or other liability incurred by or made against me as a result of any movement of horses to the Event/Farm.

1. All horses will be shampooed, rinsed and allowed to dry, and their hooves will have been picked clean of all solid material and washed with shampoo.
2. All vehicles and equipment accompanying the animals will be cleaned to remove all solid material that could contain disease agents, and then disinfected.
