## CONDITIONS:

1. The Bell Show Campdraft is a sport run by volunteers of the Bell Show Society, as a committee, we ask that all competitors treat all our volunteers with respect. The Bell Show Society reserves the right to refund nomination fees and ask any competitor to leave the Bell Show Grounds who is found by the committee to be behaving in an inappropriate manner towards any of our volunteers.
2. The Bell Show Campdraft Committee reserves the right to alter or amend the program in any way whatsoever and if required close nominations earlier, due to possible shortage of cattle or weather events.
3. All events to be conducted under the rule of the Qld Chamber of Agriculture Societies and the Bell Show Society where each applies.
4. All competitors compete at their own risk. Each competitor must acknowledge that it is a condition of acceptance of their nomination that neither the Bell Show Society Inc nor the Western Downs Regional Council will be responsible for any injury, loss, or damage.
5. **Helmets:** Riders under the age of 18 must wear helmets whilst mounted on a Horse. Helmets must comply with current Australian and New Zealand safety standards and must be securely fastened under the chin at all times.
6. **Scratching:** A 100% refund of the nomination fee will be given if the competitor withdraws more than 96 hours (4 days) prior to 8am on the first morning of the program. If a competitor withdraws less than 96 hours (4 days prior to 8am on the first morning of the program), then the entire nomination fee may be retained by the committee. If the committee deems that extenuating circumstances apply, then a refund may be granted. Each case will be at the discretion of the committee.
7. **Horse Status:** The status of a horse winning a campdraft will be determined by the highest class of horse that competes, except for Juniors, Juveniles and Encouragement Campdrafts. The winner attains the status of the highest class of horse participating (e.g., if one Open Horse competes then it is classed as an Open Draft)
8. **Status Breaking:** Running a status breaking event, rider and/or horse may break status.
9. **Stallions:** All Stallions are to be retained in accordance with ACA Rule 11.11
10. **Complaints:** Any competitor who wishes to lodge a complaint must lodge the complaint in writing with the Secretary of the Bell Show Society Campdraft Committee within one hour of the incident taking place. A fee of \$20 (cash only) must be lodged with the complaint. If the complaint is dismissed by the Committee, the \$20 is forfeited.
11. In the case of any exotic animal disease outbreak occurring prior to or during the Campdraft, all equine animals must remain at the Bell Showgrounds and abide by the DPI rulings and guidelines at that time. All costs incurred are to bourn by the competitor and in no way is the Bell Show Society Inc. liable for the expenses in the case of a lock-down.

Non-compliance may mean that your horse may not compete at the Bell Show.

### HORSE AND RING REGULATIONS:

In the case of any exotic animal disease outbreak occurring prior to, or during the show, all equine animals must remain at the Showgrounds and abide by the Biosecurity Qld DAFF rulings and guidelines at that time. All costs incurred are to be borne by the exhibitor and in no way is the Bell Show Society liable for expenses in case of lock-down.

The Chief Ring Steward shall have the final say in all decisions regarding the event and entrance into events. The Chief Ring Steward has the ability to alter or remove any event in the Bell Show Schedule

All persons shall pay for admittance to the show the sum prescribed, unless otherwise provided with a Pass from the Secretary.

All colts and stallions, 2 years of age and over, must be shown with a bit in the mouth and a safe head stall and lead. Stallions must be controlled by a person 18 years of age or over.

Competitors are advised to bring their own panels or appropriate fencing to secure their stock if camping over-night. No horses to use cattle yards for penning prior to or during the show.

Suitable attire and footwear must be worn in the ring. Singlets, thongs and similar attire are not permitted. No young children/prams allowed in the ring. Children under 18 years must wear helmets.

Stewards and Officials have the right to evict any entry in the Horse Ring which may appear to be ill, is of questionable soundness or is acting in an unsafe and uncontrollable manner. The Show Society reserves the right to reject any nomination without explanation. Horses deemed unfit or unsafe will be asked to retire from all further events.

Bell Show Society recommends competitors have their own current public liability policy if showing animals.

Exhibitors are not to transport any horse showing signs of illness onto the Showgrounds or knowing these animals have been in contact with other horses which have contracted any illness/disease prior to the event.

Immediate disqualification for ANYONE riding in the show ring the day before, and the day of the show, before events start. The pony club grounds will be available to exercise your horses.

To be eligible for Pony Club prizes, riders must be financial members of the Bell Pony Club for 2026.

To be eligible for Australian Stock Horse Society prizes, horses must be registered with the ASHS for 2026.

The Challenge Drafts will drop a peg, therefore your horse will NOT lose its Maiden Status.



14. Any horse may enter an Open event. Excluding futurity horses, who can only compete in the Futurity.
15. A rider in the Open and Intermediate classes can only ride a total of three (3) times in the day (ie 3 different horses). Competitors will be numbered and expected to ride in that order. Competitors must have completed the first four (4) phases to be eligible to compete in the Draft on Sunday.
16. Juvenile riders may either compete as a Juvenile (and have two rides) or as an Intermediate (and have 3 rides), but cannot compete in both Challenges.
17. Junior riders can only ride once.
18. Outside assistance is not allowed. Disqualification may occur.
