

## Saddlery & Dress :

Riders must compete as per CCA 'GENERAL RULES' 11. 1

Competitors must wear a hat or safety helmet, boots, collared buttoned long sleeve shirt & long trousers in competition at all

times. Caps are not permissible. Competitors must be neat & presentable.

**HELMETS RULE – \*\*UPDATED 16/8/2025 Current & Compliant Helmets must be worn at all times when on horseback.** They must comply with current Australian & New Zealand safety standards & securely fastened under the chin at all times."

Camping, water, horse yards, and toilets are available. Please \*\*clean up all rubbish and horse manure\*\* at the yards and float sites.

Club FINALIST SASHES up to 6th place after each event. Riders should be mounted whenever possible.

Prizemoney as per (Sweepstake Rule 13), with extra \$100 for the Restricted Open

Placings as follows: 1st 25%; 2nd 21%; 3rd 18%; 4th 15%; 5th 12%; 6th 9%

The program is affiliated with CCA under the "CCA Rules & Guidelines." Competitors must adhere to all CCA and Campdrafting Tas Inc Club Rules, as well as Safety Requirements and Codes of Conduct.

## CLUB SCRATCHING RULE : (Updated 6/8/22)

Scratchings, after the Tuesday deadline, must be accompanied by a medical certificate or a certificate for the horse, to receive a 50% refund only.

On the Day : make 2 members of the Executive aware of your decision & show these persons via physical exam/photo/video inform the Scorer and/or Judge of your decision (50% of entry fee Refunded—Updated 6/8/22)

## FINALS QUALIFICATIONS

- Horses need to have completed 2 Drafts in the Event you wish to compete in at the Finals.
- CHALLENGE - You must compete in 2 Challenge Events to be eligible to enter the Finals MAIDEN Draft.
- If you have competed in 2 Drafts in any event you are then able to enter the Open Final if you wish.
- FINALS Open Draft is open to all horses who have completed the 2 draft qualification rule that season. If a horse changes status, late in the season, it is then granted entry in the higher status level event.
- If you have suffered any Hardship you may apply to the Exec Committee for a review.

## APPEALS & PROTESTS : as per CCA Rule 10

Status of a horse winning a campdraft will be determined by the highest class of horse with exception of Juniors, Juveniles, Ladies, Mens, Futurity, Old Buffers, Associates and Encouragement Campdrafts. The winner attains the status of the highest class of horse participating e.g. if one Open horse competes then it is classed as an Open draft.

DOGS are not encouraged at Campdrafts and should be kept on a Leash or Tied Up AT ALL TIMES.

## SEASON Hi Points

15 for 1st, 10 for 2nd, 7 for 3rd, 5 for 4th, 3 for 5th and 1 for 6th placing in each event over the campdraft season.

Event Hi Point winners presented with Awards at Annual Dinner.

## Horse Substitution

Following illness/injury occurring after Tuesday night, a horse of a similar status may replace the initial entry.

\* No additional events may be entered and any events the replacement horse is not eligible for are considered to be a scratching

& entry money forfeited. Please notify the Secretary if substituting a horse.

## CODE OF CONDUCT —

Members, Volunteers and Spectators are required to adhere to the Club's & the CCA CODES OF CONDUCT. Members and competitors should always be aware that campdrafting is a family sport and should whilst competing, dealing with organising committees, other members and volunteers act with integrity, sportsmanship and courtesy. Competitors should always keep in mind that many members of the organising committees & cattle donors are volunteers who do not compete themselves. They deserve the utmost respect for the sacrifices they have made which enables our members to compete.
