TERMS & CONDITIONS

- **AFFILIATION:** Program is ACA Affiliated and run in accordance with the 'General Information Competition Rules & Guidelines'.
- **MEMBER & HORSE DETAILS:** ACA requires all Competitors to ensure all details mirror that of their ACA member and horse profiles, across all non Campdraft One nomination platforms.
- **MEMBERSHIP:** Event membership is welcome. ACA office must be contacted and pay \$25 for casual membership profile. \$100 is then payable to the Gold City Committee with nomination fees.
Riders must be ACA members to ride and compete in and around the Equestrian Centre. It is a condition of entry at all ACA affiliated campdrafts that each and every competitor in campdraft events accepts the total and absolute personal responsibility for the risks involved during such event. Any 'unfinancial' member that compete will be referred to the Code of Conduct Sub-Committee.
- **OPEN AGE EVENTS DISCLOSURE:** All ages are permitted to compete in Open age drafts unless otherwise specified on the program.
- **COVID-19 AWARE:** Please do not participate or enter the Equestrian Centre grounds if you are unwell.
- **RESTRICTIONS:** Limited to 8 first round runs (excluding Futurity & Restricted Open)
- **PRIZE MONEY:** Will be paid in accordance with ACA rules & guidelines. Rules R8 & R9. No prizemoney will be paid out on the weekend. All prizemoney paid out through Campdraft Central, please ensure your correct bank account details are entered.
- Juveniles wishing to incur points in a Maiden, Novice or Open draft must pay adult membership.
- **HELMETS:** Riders under the age of 18 must wear helmets whilst mounted on a horse at all ACA-affiliated events, in and around the Equestrian Centre. Helmets must comply with current Australian and New Zealand safety standards and must be securely fastened under the chin at all times. .
- **NOMINATION:** Your ACA membership number must be provided otherwise your nomination will not be processed.
- **COMPLAINTS:** Any competitor who wishes to lodge a complaint must lodge the complaint in writing with the Secretary of the host committee within one (1) hour of the incident taking place. A fee of \$100 must be lodged with the complaint. If the complaint is dismissed by the Committee, the \$100 is forfeited".
- **SCRATCHING:** A 100% refund of the nomination fee will be given if the competitor withdraws more than 168 hours (7 days) prior to 8:00am on the first morning of the program. If a competitor withdraws less than 168 hours (7 days prior to 8:00am on the first morning of the program), then the entire nomination fee may be retained by the committee. If the committee deems that extenuating circumstances apply, then a refund may be granted. Each case will be at the discretion of the committee.
- **HORSES STATUS:** The status of a horse winning a campdraft will be determined by the highest class of horse that competes with the exception of Juniors, Juveniles, Ladies, Mens, Old Buffers, Associates and Encouragement campdrafts. The winner attains the status of the highest class of horse participating (e.g. if one Open horse competes then it is classed as an Open draft).
- **ENCOURAGEMENT:** An Encouragement campdraft competitor shall be 17 years and over and one who has not won 1 Encouragement or 1 Open age draft, or placed 3 times in an Open age campdraft.
- **FUTURITY:** As per ACA rule 8.1. A. Futurity campdraft is for horses aged up to a maximum of 5 years and under. B. A horse's age will be determined as at the 1st of August each year.
- **JUVENILE/JUNIOR/MINI:** Juvenile (13 years to under 17 years) and Juniors (8 years to under 13 years) and Mini (under 8 years).
- **STALLIONS:** All stallions are to be contained in accordance with Rule 11.11 of the ACA Rules.
- Under no circumstances are riders to ride under the influence of drugs or alcohol.
- The Gold City Campdraft Association Inc. does not accept any responsibility/liability for any accident, damage, injury or illness to horses, riders, beasts and spectators or property whatsoever.
- Biosecurity forms **MUST** be completed, signed and sent to the Secretary before unloading at the Equestrian Centre. Forms will be available on Campdraft Central. The PIC for the Equestrian Centre is QJDP0366.
- No horses are to be kept in the backyards, saleyards or rodeo pens.
- Camping space is limited – **please BYO generator**. Please be mindful when marking your area.
- Pre-erected fences will be removed!
