

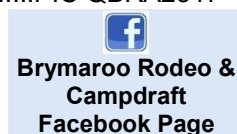

CONDITIONS OF ENTRY:

1. Program is Campdraft Central Association Inc. affiliated & run in accordance with the 'General Information Rules & Recommendations'
2. The Brymaroo Campdraft Committee does not accept responsibility for any accident, damage, injury or illness to horse, rider, spectator, or any other person or property whatsoever
3. Nominate Horses in the order you wish to ride them
4. Judge's decision in all cases is FINAL.
5. All campdrafts are to be won outright.
6. The Committee reserves the right to alter, delete or adjudicate on any event.
7. The decision of the committee on all matters pertaining to the competition shall be final, conclusive and binding on all nominations for the events.
8. No CHANGING of Horses or Riders 60 mins prior to the commencement of the draft. In the case of the first draft of the day, changes must be completed by 5:30pm the previous day.
9. If a competitor changes a nomination (horse/rider) from the original draw after the start of that event, that run may be disqualified at the committee's direction unless when extenuating circumstances apply.
10. All riders Under 18yrs MUST wear approved helmets while riding on the grounds (refer to Rule 19 of CCA General Rules and Guidelines).
11. Any competitors who, in the opinion of the Executive Committee and/or Chief Steward, deliberately mistreats or abuses stock will be disqualified from the event and also from participating in any further events on the program. No refund of nominations will be offered.
12. Under no circumstances are members under the age of 17yrs permitted to ride/handle stallions within the perimeter of the grounds
13. All stallions are to be contained.
14. All dogs must be always kept on a leash and/or be kept securely tied up whilst on the grounds.
15. Once a draft has commenced, under no circumstances is any competing rider or person on horseback permitted to exit the Camp Area via the side entry gate to the Camp. All persons cracked off in the camp must exit the camp via the front camp gates. This is for the safety of all riders, horses and persons
16. The Brymaroo Campdraft Committee has the right to refuse competitor's nominations.
17. A 100% refund of the nomination fee will be given if the competitor withdraws before closing access for the draws. Full nomination will be withheld from when the draws are being organised.

I AGREE TO ENSURE THAT:

1. All horses, vehicles and equipment accompanying horse/s will be clean and free of solid material (that could contain disease agents) prior to departing property of origin.

I FURTHER DECLARE THAT:

2. The information contained in this Biosecurity Declaration is true and correct to the best of my knowledge.

3. I Agree to abide by all conditions that may be imposed at any time by the Event Organising Committee/Biosecurity Manager

4. I acknowledge that in failure to comply, I may be directed to leave the event and my nomination will be forfeited.

5. I acknowledge that decontamination and disinfection procedures may be required of me if instructed by the Event Organising Committee/Biosecurity Manager

6. I acknowledge that there is a possibility that horses might become infected with disease agents as a result of any movements and if necessary horses and premises will be quarantined in accordance with any legislation covering such occurrences including policies and procedures in effect at that time. A agree and acknowledge that the Biosecurity Manager/Event Organising Committee, its State or National Affiliated bodies and their members are not in any way liable for any cost, expense, loss, damage, claim, action, proceeding or other liability incurred by or made against me as a result of any movement of horses to the event/farm.
