NOMINATIONS (open to the first 500 nominations only)

Nominations will be restricted to local competitors on a postcode by postcode acceptance, starting with 4423 and expanding as numbers permit.

Nominations open 8am Monday 21st September for 24 hours. Nominate online via Campdraft Central <u>https://www.campdraftcentral.com.au</u> Nominations to be paid in full by 5pm Thursday 24th September.

Maximum first round starts across the campdraft program:

- 2 x first round starts per horse (excluding Juvenile & Junior)
- 8 x first round starts per competitor

SCRATCHINGS:

A 100% refund of the nomination fee will be given if the competitor withdraws more than 168 hours (7 days) prior to 8:00am on the first morning of the program. If a competitor withdraws less than 168 hours (7 days prior to 8:00am on the first morning of the program), then the entire nomination fee may be retained by the committee. If the committee deems that extenuating circumstances apply, then a refund may be granted. Each case will be at the discretion of the committee.

FOOD VENDORS AND BAR OPERATING SAT/SUN

<u>Please note:</u> In accordance with Liquor Licensing and QldGov. CovidSafe guidelines it is a legal requirement that patrons/spectators remain seated while in Bar/Spectators area.

BYO CHAIR & REMAIN SEATED.

Conditions

- 1. All competitors compete at their own risk.
- 2. The committee reserves the right to alter or amend the program depending on number of nominations received and the availability of stock.
- 3. Nominations must be paid in full for entries to be accepted.
- 4. Horses MUST be named. Competitors please state preference order in which horses are to be run.
- 5. The judges decisions is final in all drafts.
- 6. Any competitor who wishes to lodge a complaint at an affiliated Campdraft must lodge the complaint in writing with the Secretary of the host committee within one hour of the incident taking place. A fee of \$20 must be lodged with the complaint. If the complaint is dismissed by the committee, the \$20 is forfeited.
- 7. Each competitor must acknowledge that it is a condition of acceptance of their nomination that the P&C and Campdraft Committees will not be responsible in respect of injury, loss or damage.
- 8. Riders under the age of 18 must wear helmets whilst mounted on a horse at all ACA affiliated events. Helmets must comply with current safety standards and must be securely fastened under the chin at all times.
- 9. The status of a horse winning a campdraft will be determined by the highest class of horse that competes with the exception of Juniors, Juveniles, Ladies, Mens, Old Buffers, Futurity, Associates and Encouragement campdrafts. The winner attains the status of the highest class of horse participating (e.g. if one Open horse competes then it is classed as an Open draft).
- 10. Every person who competes at an ACA affiliated Campdraft must now be a full member of the Association.
- 11. Prize money to ACA guidelines R.8 & R.9(b).

By attending the Glenmorgan P&C Encouragement Campdraft 2020, all attendees agree to abide by the COVIDSafe plan put in place by the ACA & Glenmorgan State School P&C. Failure to comply will result in your immediate discharge from the premises, risking fines, and possible banning from future events. <u>The committee reserves the right to evict any person not</u> complying with the rules.

<u>Please note:</u> NO bar/canteen for Friday night camping, 2ND October 2020. Meals available from the Bottle Tree Inn, reservations are essential ph: 07 4665 6727

- Competitors who wish to camp will be permitted to enter the grounds from 3pm on Friday 2nd October 2020.
- On arrival, all attendees will be given a wrist band as proof or signing in, that <u>MUST</u> be worn for the entirety of their stay. Attendees seen without a wristband will be required to sign in immediately.
- All campsites **MUST** be at least 15 metres apart and numbers limited to 10 people per campsite at all times.
- Competitors with their own toilet and shower facilities within their own campsites are asked to use them instead of the grounds facilities to assist with staying within the COVID plan.
- <u>ALL</u> Attendees, including Officials, Volunteers, Competitors and Spectators plus partners and children <u>MUST</u> complete a signed Glenmorgan P&C Encouragement Campdraft COVID-19 Health Screening Declaration Form (attached to this program) upon entry into the grounds.
- It is a requirement of entry that no photos or videos of the 2020 Glenmorgan P&C Encouragement Campdraft are uploaded to any social media platforms.
- It is strongly recommended that all attendees download and use the Australian Governments COVIDSafe app while at the event.
- If you are feeling unwell in anyway, <u>DO NOT ATTEND.</u>
- If you have any concerns about yourself or anyone else complying with the COVIDSafe guidelines, please contact a committee member (Secretary's box) ASAP.
- In line with current restrictions, all patrons/spectators to the bar/spectators area <u>MUST</u> provide their own seating and remain seated.
